

# Jack Jumpers Retail Competition

## Terms and Conditions

---

### 1. Promoter

The Promoter is Huon Aquaculture Company Pty Ltd (ABN 86 067 386 109) of Level 12, 188 Collins Street, Hobart Tasmania 7000 - Telephone 0448311503

### 2. Promotional Period

Entries for the competition commence at 12pm (AEST) on 1 November 2024 and close at 12pm (AEST) on 10 January 2025 (**Promotional Period**).

---

### 3. Eligibility

- (a) To be eligible for the competition, entrants must be an individual over the age of 18 years, an Australian Resident and accept these Terms and Conditions.
  - (b) Employees of the Promoter and their immediate families, participating retailers and their associated agencies are not eligible to enter.

### 4. Entering the competition

To enter the competition, entrants must, in respect of each entry:

- (a) purchase any Huon product at any Tasmanian retailer;
  - (b) scan the competition QR code found in store, online via social media or on print media, and complete the entry form on the Huon website;
  - (c) upload photographic proof of purchase when completing the entry form;
  - (d) subscribe to Huon's email mailing list and have "marketing flag yes" at the time of the draw.

### 5. The Prize
